ACKNOWLEDGEMENT/AGREEMENT: Please read and initial each line if you are in agreement. If any item does not meet your approval, please state the reason below on lines provided and bring it to the attention of the Branch Administrative Assistant or Branch Director.

1. _____ I understand that the club is closed on the following holidays: New Years Day, Thanksgiving Day and the day after, Christmas Day and the day after (or before), July 4th, Labor Day, and Memorial Day. From time to time there will be other days closed, which will be posted in advance.
2. _____ The Boys & Girls Clubs of Greater Scottsdale has my authorization to use photographs, reproduction, and any sound recording of my child. Such use may include advertising and publicity purposes. (I attest that my child's identity is not under protection furthermore, he/she is not under foster care, court order or protective custody.)
3. _____ I approve the administration of pre/post surveys as well as online evaluation tools to my child while he/she is participating in the Boys & Girls Clubs of Greater Scottsdale program. I understand these results are helpful in evaluating the effectiveness of the program, that the information is strictly confidential, and that copies of the surveys/tools are available to me upon request.
4. _____ I understand that I will be notified should my child become ill or have behavioral issues during the day, and that it will be necessary to make arrangements to have my child leave or be picked up as soon as possible after notification. If my child is exposed to a contagious disease, I agree to notify a full time staff and agree that my child may not be permitted to attend the program. I understand that my child may not be permitted to attend the program until a physician has granted permission in writing.
5. _____ I understand that the Boys & Girls Clubs of Greater Scottsdale reserves the right to suspend or terminate my child's enrollment from the Club if my child exhibits poor behavior. It is my responsibility to meet with the Branch Director or Youth Development Supervisor to discuss any matter of concern on either the Clubs' part or mine.
6. _____ Boys & Girls Club staff members are available to help address questions, concerns or suggestions. Major questions or concerns should be addressed with the Youth Development Supervisor and/or the Branch Director. If time does not permit an immediate discussion, a meeting for review of the situation will be set. However, I understand that anyone who engages in disorderly conduct of any kind such as use of speech/language that is offensive/inappropriate or demonstrates physical/verbal abuse or threat of harm to any staff/volunteer/member, will be subject to removal and possible exclusion from the facility.
7. _____ I understand that the club is not responsible for items brought to the club that are lost or stolen.
8. _____ I acknowledge that as I am the parent/guardian signing the membership form, I am ultimately responsible for any/all monies due to the club on behalf of said member. Also, as the signing adult, I am the only person who will receive financial information and/or statements for this member. Any information

requested by a third party must be obtained by myself and passed on or requested by mail from Human Resources with a court order. No information will be released without a court order.

Technology Acceptable Use Policy

Introduction

The Boys & Girls Clubs of Greater Scottsdale has established a computer network and is pleased to offer Internet access for member use. This will allow members to have access to a variety of Internet resources. In order for members to use the Internet, their parents or guardians must first read and understand the following acceptable use policies.

Acceptable Uses

1. The computer network at BGCS has been set up in order to allow Internet access for educational purposes. This includes activities, peer review of assigned work, and the exchange of project-related ideas, opinions, message boards, and other means.
2. Members will have access to the Internet via the computers in the Club and access is limited to when those computers/areas are open.
3. Network users must respect resource limits and will only be able to save files to the computers with staff permission. Large files that may take up excessive amounts of storage space might not be allowed to save.
4. Member use of the Internet is contingent upon parent/guardian permission in the form of a signed copy of this Acceptable Use Policy. Parents/guardians may revoke approval at any time.
5. Material created and/or stored on the system is not guaranteed to be private. Network administrators may review the system from time to time to ensure that the system is being used properly. For this reason, members should expect that emails, material placed on personal Web pages, and other work that is created on the network may be viewed by a third party.
6. Network users must keep their passwords private. Accounts and/or passwords may not be shared.
7. Network users are expected to adhere to the safety guidelines listed below.

Unacceptable Uses

1. The network may not be used to download, copy, or store any software, shareware, or freeware.
2. The network may not be used for commercial purposes. Users may not buy or sell products or services through the system without prior permission from the network administrator.
3. Use of the network for advertising or political lobbying is prohibited.

4. The network may not be used for any activity, or to transmit any material, that violates United States or local laws. This includes, but is not limited to, illegal activities such as threatening the safety of another person or violating copyright laws.

5. Network users may not use vulgar, derogatory, or obscene language. Users may not engage in personal attacks, harass another person, or post private information about another person.

6. Network users may not log on to someone else's account or attempt to access another user's files. "Hacking" or otherwise trying to gain access to another person's or organization's computer system is prohibited.

7. Network users may not access Web sites, newsgroups, or chat areas that contain material that is obscene or that promotes illegal acts. If a user accidentally accesses this type of information, he or she should immediately notify a teacher, librarian, and/or network administrator.

8. Network users may not engage in "spamming" (sending an email to more than 10 people at the same time) or participate in chain letters.

Safety Guidelines for Students

1. Never give out your last name, address, or phone number.

2. Never agree to meet in person with anyone you have met online unless you first have the approval of a parent or guardian.

3. Notify an adult immediately if you receive a message that may be inappropriate or if you encounter any material that violates this Acceptable Use Policy.

4. Your parents should instruct you if there is additional material that they think would be inappropriate for you to access. BGCS expects you to follow your parent's wishes in this matter.

- I will encourage my child to shake hands with the other team at the conclusion of all games.
- I will help ensure a litter-free environment by cleaning up my trash before leaving the gym after any practice, or game.

INSTRUCTIONAL BASKETBALL LEAGUE

PURPOSE:

This is an instructional league designed to enhance the positive aspects of a competitive team sport. Each youth is guaranteed an equal opportunity and time to participate!

LEAGUE OBJECTIVES:

- 1) To teach youth that a competitive sport can be fun.
- 2) To allow each participant an equal opportunity to learn and achieve.
- 3) To improve the basketball skills and muscular development of youth.
- 4) To allow any youth, regardless of talent and ability to participate.
- 5) To teach respect of rules.
- 6) To foster cooperation between members, teams and clubs.
- 7) To teach good sportsmanship.

MISSION OF BOYS & GIRLS CLUBS OF GREATER SCOTTSDALE

The mission of the Boys & Girls Clubs of Greater Scottsdale is to provide a positive environment, quality programs, healthy lifestyles and lifelong learning skills for school-age youth in Scottsdale and surrounding communities.

To accomplish this Mission, it will take the support of spectators, parents, coaches, officials and the Boys & Girls Club staff!

Support all members in a positive way!!

MEMBERSHIP RULES: All youth must be a member of the Boys & Girls Clubs of Greater Scottsdale. If a youth is playing on his/her school team, no special allowances will be made for their missing games or practices. Once they have missed more than two (2) games or practices, they may be placed in the reserve pool. Let it be known at the beginning of the season that all players in each division must be prepared to play at the US Airways Arena.

All youth may sign up beginning September 19, 2011. A youth may be 14 years old during the season and participate, but must be in middle school. The Suns League is for 12 and 13 year olds. The Cadet League is for 10 and 11 years olds. The Rookie League is for 8 and 9 year olds.

No Boys & Girls Club member may participate in more than one league per season. If a member chooses to participate in the Suns League, he is not eligible for Cadet League competition. Same holds true for the Cadet and Rookie Leagues. This rule also pertains to All-Star competition.

FEES: \$25 Annual Membership Fee
School Year Club Hours: Monday - Friday 2:30-8:30 p.m.

Boys and girls are welcome at all Club activities.

\$100 Basketball Fee - NO REFUNDS - pays for equipment, officials, supplies and uniform that the player gets to keep.

RESERVE POOL: When the Rookie, Cadet, and the Suns League rosters are filled, we will start a reserve pool. If a player quits, moves or is removed from a team, that spot will be filled from the reserve pool with parity in mind.

REGULAR SEASON: The regular season will consist of at least eight games for each of the three leagues to be played December – February. All-stars and tournaments will follow.

PLAYOFFS:

Every team will make the playoffs. All three leagues will be played with an “A” Division and “B” Division format with two (2) playoff champs in each League. It is possible that they may play on different nights than the regular season. Please check with your coach for the playoff schedule. Due to the fact that regular season standings determine what division playoff you will be in, announcement of playoff games and times may be announced approximately 24 hours prior to the game.

**A.I.A. COACHES
TRAINING & CLINICS:**

The Boys & Girls Clubs of Greater Scottsdale assures that our coaches are aware of their responsibility to your child. Information on a child’s psychological and emotional needs, first aid and proper sports teaching techniques are included in the program. One coach from each team will be REQUIRED to complete this training. We also provide clinics for our coaches using local college and high school coaches, as well as a referee’s clinic to review up- to- date rules and changes.

PRACTICE:

IT IS MANDATORY! Normally, practice will be twice a week. It is each player’s obligation to attend every practice. If missing practice becomes a problem, playing time may be limited to one quarter. If the problem worsens, the player may be put in the reserve pool. Please make every effort to contact your coach if a practice must be missed. The Boys & Girls Clubs do not schedule practices, therefore, we do not know when and where teams practice. Only your coach or your child’s teammates know.

CITY CHAMPIONSHIPS:

Champion and runner-ups from IN-HOUSE DIVISION A TOURNEY will represent Piper Branch in all the age divisions in the CITY CHAMPIONSHIP.

REFEREES:

Generally, most of our referees will be AIA Officials. If AIA Officials are not available, then trained Boys & Girls Clubs staff members will referee the games. AIA officials are doing the Boys & Girls Clubs a big favor by coming here and officiating. No abuse of these individuals will be tolerated. Remember, the children are not here to win or lose, they are here for instruction on how to play.

AWARDS CEREMONY: Ceremony dates are tentatively set for February 27-28 The ceremony is for **parents and players only!**

ANNUAL T.V. RAFFLE: Each player will be given \$40 worth of raffle tickets. Players need to turn in \$20 and all the ticket stubs to their coach. Players can sell all of the tickets and keep \$20, OR sell \$20 and use the other \$20 worth for themselves OR pay \$20 and use all of the tickets. The raffle will be held on March 2rd. This fund-raiser is vital to the existence of our Basketball Program.

TEAM PARENTS: Every team needs assistance for a successful season. Team Parents can be helpful at ceremony time, to call parents for practice, or team meetings, and also help with the T.V. Raffle. Please volunteer your time. See your child's coach. The truly successful teams have an active Team Parent.

PICTURE DAY: Picture Day is a service provided by the Boys and Girls Clubs through a professional photographer. It is a nice way for you and your child to remember their teammates and their experience in years to come. **Picture Day is January 14th.** Be on time, as there is no re-scheduling.

DRAFT: Every player makes a team, there are no cuts. The draft is simply a selection process by the coaches to place players on a team. Draft days are as follows:

Rookies Tuesday, November 1st
(8 year olds 6:00pm; 9 year olds 7:15 pm)

Cadets Wednesday, November 2nd
(10 year olds 6:00pm; 11 year olds 7:15pm)

Suns Thursday, November 3rd
(12 year olds 6:00pm; 13 year olds 7:15pm)

Do not call the Boys and Girls Clubs the day after the draft to find out what team your child is on. Your coach will contact you within 5 business days after the draft.

**PLAYER, PARENT,
COACH AND STAFF
MEETING:**

This is a mandatory meeting that will be held @ each teams first on site practice at the Piper Branch. Individual team times will be available from your coach.

This is a very important meeting, please make plans to attend.

GAME RULES AND REGULATIONS

UNIFORMS:

The Boys & Girls Club will provide a uniform (shirt and shorts) that is mandatory for members to wear. Each player must wear the assigned uniform and cannot wear another shirt or pair of shorts in place of those originally given to them. Uniforms are for members to keep at the end of the season. It is also mandatory that players wear court shoes.

ATTENDANCE:

Each member of a team is required to be in attendance for every game in which their team is a participant. All members are required to be on time! It is the responsibility of the coaches for each team to see that their players are in attendance for all games. The players should be telephoned the day before and reminded of games and practices. They are to be in full uniforms. Team Parents are recommended to assist. Coaches are recommended to select a Team Parent to help with all team situations.

FORFEITS:

A team must have five members present to start a game or the game is considered a forfeit. In case neither team has the required amount of members present, the game is counted as a loss for both teams.

**MINIMUM
PLAYING TIME:**

Each player must play twelve (12) full minutes in each game that they are present. It is highly recommended that all coaches play each member more than the required time in each game. (Excluding Injury or Illness).

**DEFENSIVE
RULES:**

When Team “A” takes the ball out in the backcourt area, either after a made basket or a turnover, Team “B” cannot interfere with Team “A” until the ball crosses the half court or 10 second line. In case of a live-ball change of possession, there may be defensive pressure depending on the transition flow of the offense. If the offense chooses to walk the ball up the court, the defense must drop back. This ruling is at the discretion of the official. A full-court press will be permitted the last two (2) minutes of each half in the Rookie and Cadet divisions. The Suns division may press any time. Teams, when behind by twenty (20) points or more, may press at any time.

ZONE DEFENSE: High School rules apply for each division.

TIMEOUTS: Each team is allowed four (4) time-outs per game. Each time-out will be one minute in duration.

TIME: There will be four (4) quarters per game. Each quarter will be eight (8) minutes in length running time. The clock will stop for time-outs and foul shots. The clock will stop while an official is reporting a foul to the scorer’s table. If it is not a shooting foul, the clock will start when the official hands the ball to the player. The clock will also stop on each whistle during the last two (2) minutes of each half in the Cadet and Suns Division and only the last two (2) minutes of the game in the Rookie Division. The clock continues to run if there is a twenty (20) point lead.

OVERTIME: Overtime period will be three (3) minutes stop time, as a continuation of the fourth quarter. Each team will be issued one extra time-out for the overtime plus any additional time-outs they had remaining at the conclusion of regulation.

**BONUS AND
FOUL SHOTS:**

In each half, bonus foul shots will be taken on the 7th team foul. Two (2) shots or double bonus is in effect upon the 10th team foul.

COACHES:

Since this is an Instructional League, coaches will be allowed to roam the length of the bench for instruction to

players only. **Coaches are required to display good sportsmanship and respect toward the officials.** Any coach who is ejected (2 technical fouls) from the game, is automatically suspended for their team's next game and is subject to suspension from the league. **One coach is permitted to be standing within the coach's box (as designated).**

CONDUCT:

All players, coaches, and spectators are expected to display honesty, fair play and sportsmanship at all times. The Boys & Girls Club staff reserves the right to suspend players and remove spectators at any time for behavior that is not conducive to Boys & Girls Clubs standards.

POINTERS:**

In each division, the three (3) point line is in effect.

OTHER:

Any other rulings not covered, will follow the AIA State High School Association rule book, 2010-2011.
